**DATE AND TIMES:** First off, F. Co. Annual Camp of Instruction is set for the weekend of March 22<sup>nd</sup> – March 24<sup>th</sup>. **Tactical Event (5-7 April 2013)**

The company commander has asked me to do a short write up on the upcoming April tactical. This event sponsored by Rear Rank Productions and the Southern Division offers our company a real opportunity to experience real Civil War soldier life in the field. This is a judged tactical event rather than your usual battle re-enactment, which means it's not scripted and line judges will periodically be assessing our capabilities. To understand the philosophy of this event you need to access the event website at hookersrear.com which will provide you w/relevant event information, however, some key points for your personal planning:

**Directions** Go to website heading "Logistics" for specific directions to the event which is west of Fredericksburg. Additionally this heading will explain the support for firewood, water, and sanitation.

**Rations** You need to be prepared to feed yourself from you haversack for 36 hours. The website heading "Resources" has excellent information on formulation of your rations. Precooked rations would be an excellent idea, however, given that you want a hot meal on Sat evening then you need to work on assembling yourself a mess w/period cooking gear such as small pot, skillet, etc.

**Ammunition** Recommend you bring 80 rounds of blank ammo, w/40 rounds in your cartridge box and 40 rounds in your knapsack or blanket roll.

**Bivouac** You'll be sleeping in the field w/whatever you can carry, so tentage isn't really an option. Whether or not you'll have access to your vehicle for additional support is subjective, so make plans to live and subsist for 36 hours on your own which protection from the rain and other possible adverse weather, that is overhead cover, ground cloth, gum blanket, etc.

**Arrival/Departure** I'd strongly recommend that you arrive at the site on Fri afternoon or evening so that you'll really be ready to go first thing on Sat morning. Event should be concluded by Sun afternoon.

Merge onto I-64 W via EXIT 53A toward CHARLOTTESVILLE. 2.5 mi

Merge onto VA-288 S/WORLD WAR II VETERANS MEMORIAL HWY via EXIT 175 toward CHESTERFIELD. 12 mi

Merge onto US-60 W toward POWHATAN. 8.5 mi

Turn LEFT onto DORSET RD. 1.6 mi

DORSET RD. becomes SCHROEDER RD. 3.3 mi

SCHROEDER RD. becomes GENITO RD. 3.6 mi

GENITO RD. becomes VA-604/CHULA RD. Continue to follow CHULA RD. 1.8 mi

Turn LEFT onto COVERLY RD.
